### ARRL NW DIVISION NEWSLETTER - MAR 23, 2022

It was wonderful to peruse the treasures vendors brought to the events, and meet and talk to quite a few hams; quite a few I hadn't seen in person since the pandemic began in early 2020. It seems that things are slowly getting back to normal, and now I can't wait to get to Seaside, OR, and our ARRL Northwestern Division Convention at SEA-PAC in June. I'll be all over the place there, so if you see me, say HI! (The latest news regarding ARRL attendance at SEA-PAC later in this newsletter.)

#### US FOREST SERVICE EXTENDS COMMENT PERIOD ON NEW FEES

On February 22nd ARRL Legal Counsel, David Siddall, K3ZJ informed us that the US Forest Service has sent a Notice to the Federal Register announcing that they have re-opened the window for comments on the proposed new \$1400 annual administrative fee for amateur repeater sites on their land, and in fact, all users. This means that amateurs that may have missed the earlier comment period, or who wish to file additional arguments and information, can submit new filings between now and March 31. Please note the proposed fee is a new and separate fee, not an increase to fees (such as rent) already being paid. If adopted, the existing fee(s) – which generally have been around \$130-140 annually for amateur uses – would have to be paid in addition to the new proposed annual administrative fee of \$1400. This would put amateur installations on par with those of commercial wireless entities such as broadcasters, cellular providers and broadband entities.

The ARRL will most likely be filing a second set of comments prior to this new deadline

#### ARRL FOUNDATION NEWS

I received notice from ARRL Honorary VP and Foundation Scholarship Chair Jim Fenstermaker, K9JF, today that after several month of delays due to moving to a new web-based application and vetting process, we will start the long process vetting for the 100 plus scholarships in a few days. In addition, it's expected that at the end of April the first application window will open for the new ARRL Foundation Club Grant program. We expect to start vetting for those applications in the late June/early July timeframe. As a member of the Scholarship Committee, and recently named as Chair of the new Club Grant Application Scoring sub-committee I see lots of work in my future, as if I don't have enough already!

While we are on the subject of grants, lots of interest has been raised on the new ARRL Club grant program that will soon be available for both ARRL affiliated, and non-ARRL affiliated organizations. Grants are a great way to fund small and large projects that your club might be interested in. There is also a bit of confusion about just what some of them are, and what the differences are. Spend a few minutes to look over the websites and talk with your club, as this is a valuable resource that clubs can use to build amateur radio's future in an ever-changing technology world. Let's look at the details of the two major ARRL programs available:

ARRL Foundation Grants: These grants are awarded by the ARRL Foundation to clubs and organizations promoting amateur radio. The maximum grant is \$3000, and the specific uses of the funds are restricted to specific projects. The details of just what you can use the money for and how to apply are on the ARRL website at Amateur Radio Grants (arrl.org). There are specific times during the year to apply, and all the information is on the website.

ARRL Club Grant Program: This program is new and still in development having just been announced in January around the time of the ARRL Board of Directors meeting. This program will allow clubs to apply for up to \$25,000 for specific projects, and is funded by a \$500,000 grant from the Amateur Radio Digital Communications group (ARDC). The details of how the funding can be used and how to apply have not been formally announced yet. Stay tuned for more information on this program.

Related to the new ARRL Club Grant program, the following is from ARRL Field Services Manager Mike Walters, W8ZY, and is lifted from the ARRL Club Newsletter published on March 22nd:

"You may have heard of the ARRL Foundation Club Grants Program. More information is coming on that, but one part of the program that you may not have heard about, is a new project to provide help to clubs who are seeking grants. This is being launched along with the grants program. It entails two distinct types of club mentors.

The first is the "Club Grants Coach". This is a person that can collaborate with a club to help them create or refine a grant application. As grant applications come in there will be some that need assistance with the process. This person should be able to work with a club to help visualize and present their ideas for a grant. They will not be responsible for writing the applications, but they will be helping the clubs get organized and through the application process. Grants Coaches will start work after the first round of applications.

The second is a "Club Mentor". This person will work with a club that may be struggling to survive, helping them reorganize or structure programs to help the club grow. Some clubs are on virtual life support and can benefit from a Mentor to help them develop new outlooks and ideas and execute a rebuilding program for their club. Both positions will receive training in the processes that they will need to do the jobs and will be supported by the Field Services Team at ARRL. The expected formation of these positions is planned for over the course of the next several months as the grants program develop. NEW \$35 FCC APPLICATION FEES FOR AMATUER LICENSE APPLICATIONS SET TO START APRIL 19, 2022

ARRL FCC Counsel David Siddall, K3ZJ sent an e-mail today out announcing that the FCC has now set the date for when it will require the new \$35 fee to be collected for all amateur radio license applications that are not an administrative change, such as a change of name or mailing address. That date is April 19, 2022. The official release from the FCC is below:

"MD Docket No. 20-270

On December 23, 2020, the Commission adopted a Report and Order implementing a new application fee schedule which significantly updated the Commission's previous fee schedule.

As indicated in the 2020 Application Fee Report and Order, the new application fee rates will become effective when the Commission's "information technology systems and internal procedures have been updated, and the Commission publishes notice(s) in the Federal Register announcing the effective date of such rules."

On July 6, 2021, the Commission announced the new application fee rates for the Office of Engineering and Technology and the Media Bureau would become effective on July 15, 2021 and on December 15, 2021, the Commission announced the new application fee rates for the Wireline Competition Bureau, the Enforcement Bureau, the International Bureau, and CALEA Petitions would become effective on December 15, 2021. This Public Notice announces that the new application fee rates for the Wireless Telecommunications Bureau, codified at 47 CFR § 1.1102, will become effective on April 19, 2022.

Wireless application fees can be paid through the Commission's Universal Licensing System (ULS) at <a href="https://www.fcc.gov/wireless/universal-licensing-system.">https://www.fcc.gov/wireless/universal-licensing-system.</a>"

Three things you need to know:

- 1. All fees collected can be submitted only via the FCC ULS website by the applicant, or by somebody on their behalf. The VECs and their test examiners themselves will not be collecting any FCC fees when tests are administered. Once you pass a test you will have a certain amount of time following the application submission by the VEC to log into the FCC ULS website and pay your fee.
- 2. Fees will now be collected for each vanity call application, and NOT refunded if you do not win a competitive bid for a particular callsign.
- 3. If you are considering a vanity callsign at all, NOW IS THE TIME TO APPLY!

#### ARRL ANNOUNCES NEW INTERNATIONAL DIGITAL CONTEST

The ARRL has just released rules for a new digital HF+ contest! (The "+" because it includes six meters). As part of removing the FT-x modes from the ARRL RTTY Roundup contest for 2023 and beyond, (making the contest RTTY only), the ARRL has created a new contest aimed for fans of the FT-x, and other "non-RTTY" digital modes. This contest has a few twists in it, including the use of "distance base scoring", where the stations you work in the contest that are farther from your grid square are worth more points. Unfortunately for us here in the Northwest it falls on the same weekend as SEA-PAC, but it's hard to find a weekend that doesn't have a big contest in it.

This new contest came from a collaboration between the Program and Services Committee, (PSC), the Contest Advisory Committee, and ARRL staff.


